If the answer is yes, I suggest using Bright Futures Ltd of 92 Hertfield Avenue, Enfield, London, EN2 9QR, but would be happy to receive your alternative proposal. If the answer is no, please let me know who you would like to appoint as your surveyor.

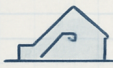
