

If a dog bit you around Atlanta, Georgia works differently than people expect.

In some places an owner is liable automatically. Georgia is not one of them. Usually it comes down to whether the owner had reason to know the dog was vicious, or whether a leash law was being broken at the time.

Proving prior knowledge is difficult. Owners rarely volunteer that a dog has snapped before, and witnesses on the same street tend to stay quiet.

The ordinance route is frequently more provable, so the early questions focus on whether the animal was restrained and whether a complaint was ever filed.

Records disappear quickly here. Prior complaints and recollections both fade, and the animal may be rehomed or euthanized before its history is ever documented.
