

What Is the Anion Gap?

The **anion gap** is a calculated value used to help assess **electrolytes** and the body's **acid-base balance**. It is one of the most helpful tools for detecting **metabolic acidosis**, especially when the cause is not immediately obvious. In practice, the anion gap helps clinicians and patients see whether there may be an excess of unmeasured acids in the blood.
