

If you were riding and a driver did not see you in Georgia, you are starting from behind.

Adjusters and jurors bring an assumption to these cases: that the rider was going too fast, was weaving through traffic, or accepted a risk nobody else would.

Occasionally that is true. More often a driver looked and did not register a single headlight.

Reconstruction matters more here than testimony, because narrative starts at a disadvantage. Sight line analysis carry more weight than either version of events.

Severity helps and hurts. A rider has no structure around them, so identical forces cause much **More helpful hints** greater harm. Expect an argument that choosing to ride was itself the risk.
