SHARED CUSTODY AGREEMENT

INTRODUCTION

DEFINITIONS

For the purposes of this Agreement, the following terms shall be defined as follows:

- 1. Shared Custody:** The arrangement in which both Parents have equal rights and responsibilities toward the upbringing of their child(ren).
- 2. Physical Custody:** Refers to where the child(ren) will live and the day-to-day care required.
- 3. Legal Custody:** Pertains to the decision-making responsibilities regarding significant aspects of the child's life such as education, health care, and religious upbringing.
- 4. Parenting Schedule:** A detailed plan indicating the timeshare and visitation arrangements for the child(ren).
- 5. Alteration:** Any agreed-upon changes to this Agreement which must be documented in writing.

CUSTODY ARRANGEMENT

1. Physical Custody

- 1.1 The Parents hereby agree to share physical custody of the child(ren) in accordance with the schedule outlined in Section 2 of this Agreement.
- 1.2 The child(ren)'s primary residence shall be established as follows:
