

What an Anion Gap Calculator Measures

An **anion gap calculator** is a practical **diagnostic tool** used for estimating the difference between routinely measured electrolytes in blood. 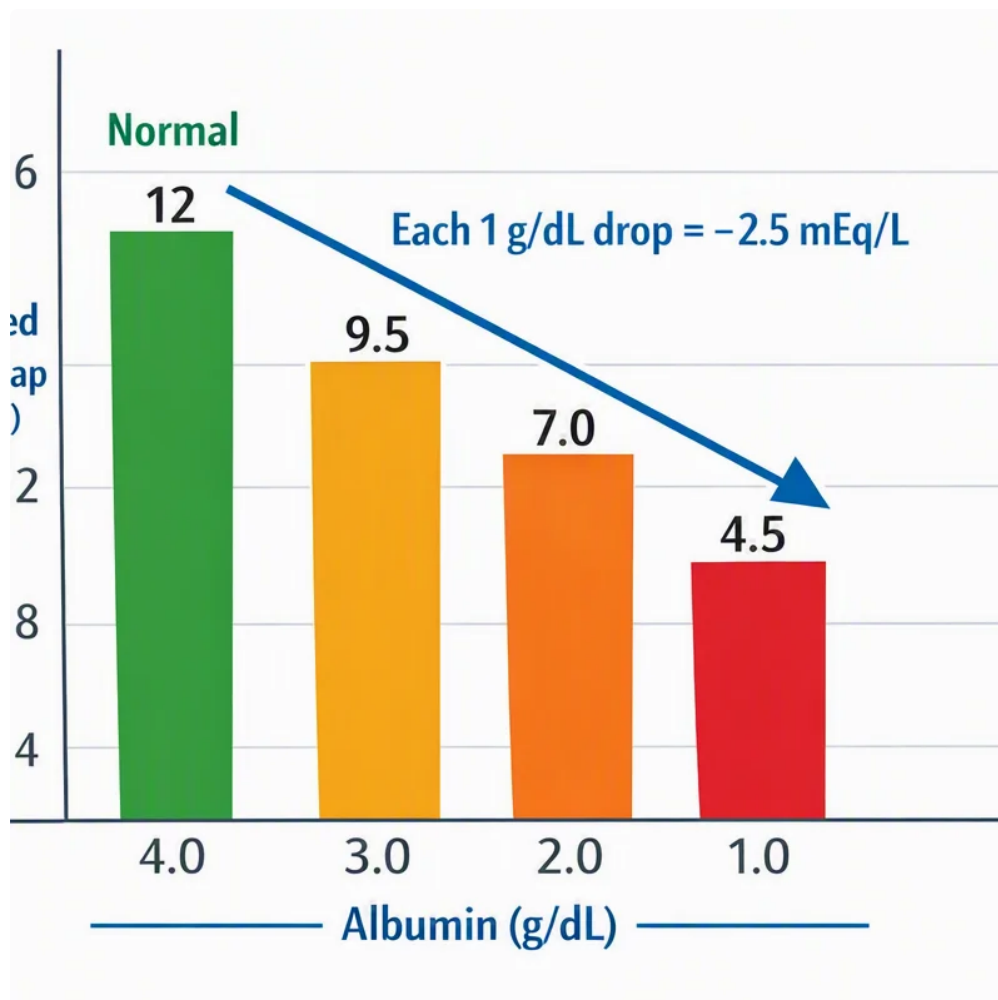
High Anion Gap Metabolic Acidosis Causes
