

If you ride and a driver did not see you in Atlanta, there is a prior you have to overcome.

There is a built in bias in motorcycle claims: that the rider was going too fast, was lane splitting [local car wreck lawyer](#) or weaving, or accepted a risk nobody else would.

Occasionally that is true. More often a driver looked and did not register a single headlight.

Reconstruction matters more here than testimony, because narrative starts at a disadvantage. Scene measurements do the arguing.

Severity helps and hurts. A rider has no structure around them, so the same impact produces far worse injuries. The defense response is often to argue the rider accepted that risk by riding at all.
