

When a rider is hurt and a driver did not see you in Atlanta, the assumption is already working against you.

Adjusters and jurors bring an assumption to these cases: that the rider was speeding, was weaving through traffic, or took a risk a car driver would not.

Sometimes it fits. Frequently the driver simply did not see the motorcycle and turned across it.
