

If a dog bit you in Georgia, the legal standard surprises most people.

In some places an owner is liable automatically. Georgia does not work that way. The claim generally turns on whether the owner had reason to know the dog was vicious, or whether a leash law was being broken at the time.

Establishing what the owner knew is not easy. Owners rarely volunteer that a dog has snapped before, and witnesses on the same street tend to stay quiet.

A leash law violation is often the clearer path, which is why the first questions are <https://www.wordspringer.com/s/jkBYkuTmtw9clwg-03DxR> about where the dog was and whether a complaint was ever filed.

These records fade fast. County records and witness memory both degrade, and the animal may be rehomed or euthanized before its history is ever documented.

How much does a personal injury lawyer cost in Atlanta?

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
