

If you were riding and a driver did not see you around Atlanta, you are starting from behind.

There is a built in bias in motorcycle claims: that the rider was going too fast, was lane splitting or weaving, or took a risk a car driver would not.

Occasionally that is true. Frequently the driver simply did not see the motorcycle and turned across it.

These cases get built on physical evidence rather than narrative, since the story is doubted before it is told. The geometry of the turn do the arguing.

Injury severity cuts both ways. A rider has no structure around them, so the same impact produces far worse injuries. The defense response is often to argue the rider accepted that risk by riding at all.
