

What the Anion Gap Evaluates

The **anion gap** is a computed value that enables clinicians interpret **electrolytes** and assess **acid-base balance**. It is based mainly on the relationship between **sodium**, **chloride**, and **bicarbonate** in a **serum chemistry panel** or **electrolyte panel**. 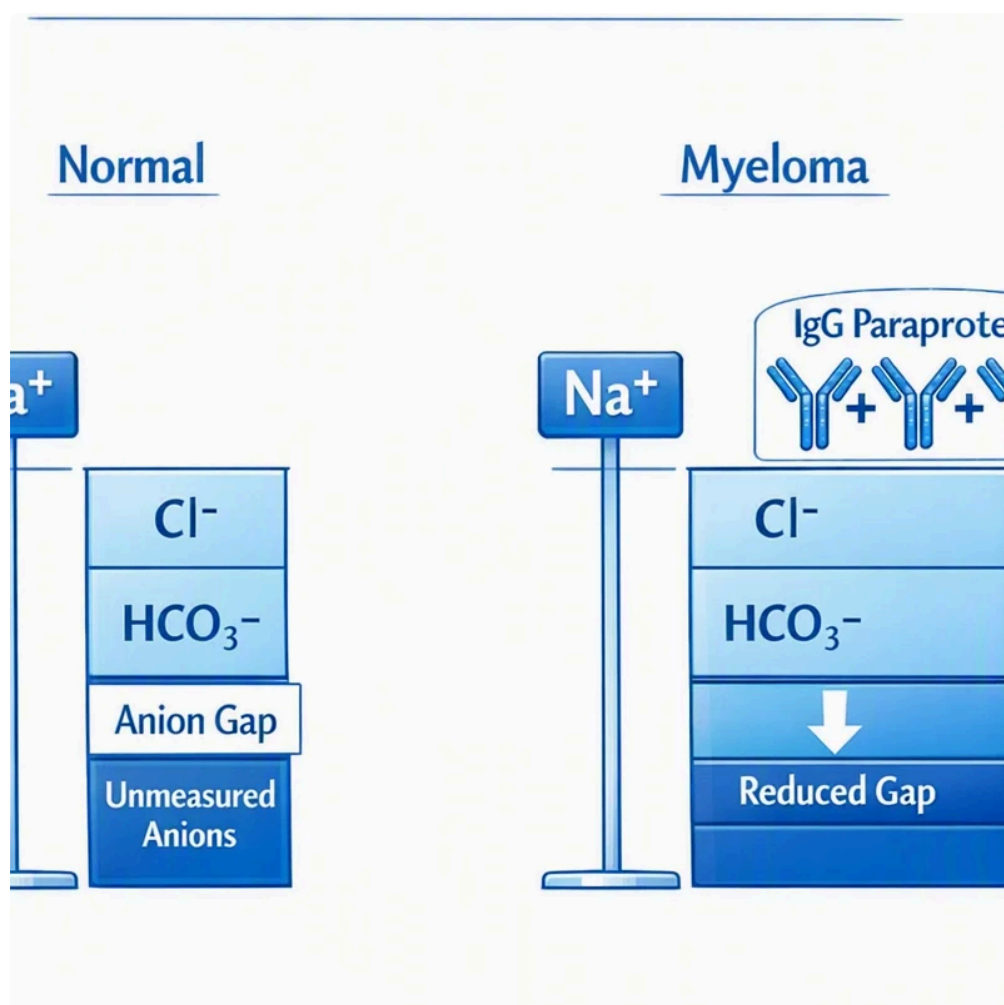
