

What the Anion Gap Suggests in Iron Overdose

The **anion gap** is a useful way to interpret an acid-base imbalance when a patient has a suspected **iron overdose**. In toxicology, the anion gap helps clinicians determine whether **metabolic acidosis** is present and whether it may indicate significant systemic toxicity. Because iron poisoning can progress rapidly, the anion gap is often part of the first-line emergency assessment alongside the patient's clinical presentation and serum electrolytes.

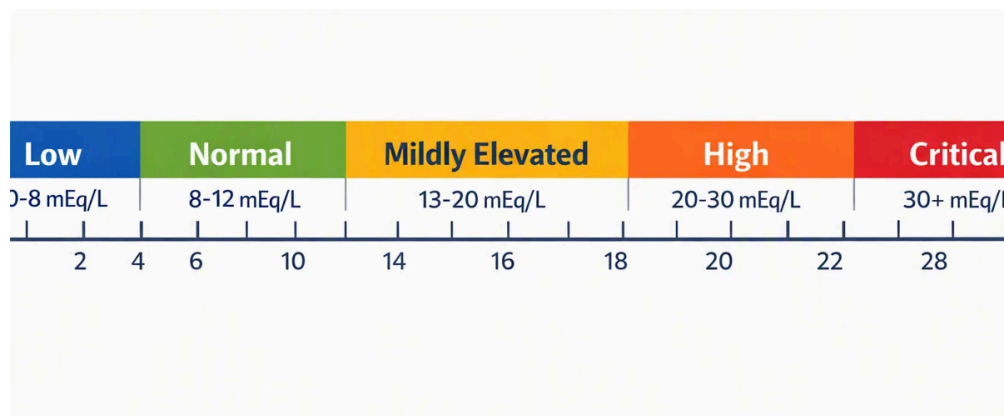
