

A rideshare wreck raises a question a normal car crash does not: which insurance policy actually applies. The answer turns on what the app was doing when the crash happened.

If the app is off, it is an ordinary car wreck, and only the personal policy is in play. Once the app is on and the driver is waiting for a request, a smaller layer of coverage generally applies. Once they have accepted a ride or have a passenger in the car, a far larger commercial policy usually applies.

That timing is not a technicality. It can be the difference between a modest policy and a substantial one, and the records that prove it sit with the rideshare company, not with you.

It matters whether you were the passenger, the other driver, a pedestrian or a cyclist. Each one can reach different policies.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
