

How the Anion Gap Shows

The **anion gap** is a computed value used in **acid-base status** evaluation to help spot an **electrolyte imbalance** or a hidden **acid-base disorder**. It reviews the major measured cations and anions in the blood and provides clinicians a clue about the presence of **unmeasured anions** that may be associated with a **metabolic disturbance**.

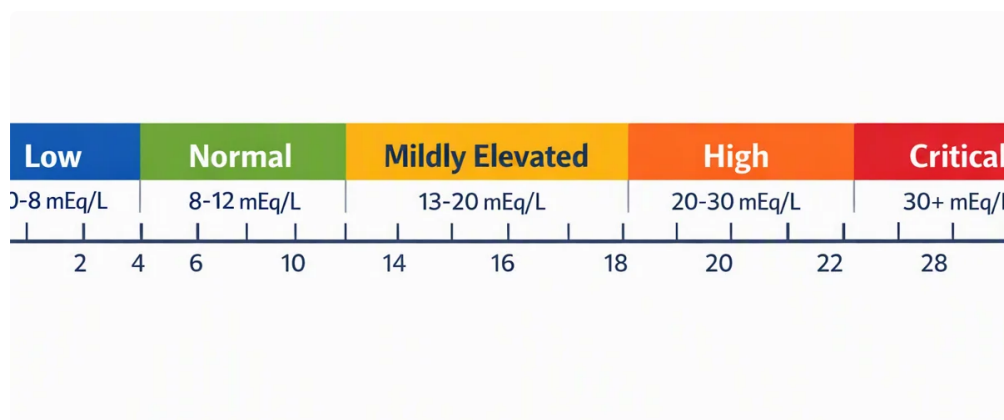
