

When a dog attack leaves someone hurt in Atlanta, the legal standard surprises [experienced car accident lawyer](#) most people.

Some states hold the owner responsible no matter what. Georgia does not work that way. The claim generally turns on whether the owner knew the animal was dangerous, or whether a leash law was being broken at the time.
