

A truck crash is not the same as a car crash. A fully loaded truck can outweigh your car many times over, and people tend to get hurt much worse.

The difference shows up immediately. The trucking company often sends its own people to the scene the same day, while you are still in the emergency room. They begin building the company's side of the case right away.

More than one company can be responsible. The trucking company, a maintenance contractor, a freight broker, or whoever loaded the trailer can each share it. Each one is a separate question with its own proof.

Commercial trucks also create records an ordinary car never does: hours **website** of service logs, engine and braking data, maintenance and inspection files, and the driver qualification file. Much of it can be overwritten or discarded on a normal schedule, which is why a preservation demand usually goes out early.
