

When a dog attack leaves someone hurt around Atlanta, Georgia works differently than people expect.

In some places an owner is liable automatically. Georgia is not one of them. The claim generally turns on whether the owner had reason to know the dog was vicious, or whether the dog was loose in violation of a local leash ordinance.

Establishing what the owner knew is not easy. Owners rarely volunteer that a dog has snapped before, and neighbors are often reluctant to get involved.

A leash law violation is often the clearer path, so the early questions focus on whether the animal was restrained and whether a complaint was ever filed.

These records fade fast. Animal control files and recollections both fade, and the animal may be rehomed or euthanized before its history is ever documented.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
