

If you or your child were bitten in the Atlanta area, the rules may not be what you assume.

Certain states impose liability regardless of the animal's history. That is not the Georgia rule. Usually it [truck accident lawyer](#) comes down to whether the owner had reason to know the dog was vicious, or whether the dog was loose in violation of a local leash ordinance.

Establishing what the owner knew is not easy. People do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

A leash law violation is often the clearer path, which is why the first questions are about where the dog was and whether anyone contacted animal control.

Records disappear quickly here. County records and recollections both fade, and the animal may be rehomed or euthanized before its history is ever documented.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
