

If you were hurt on a bus in Georgia, there is a clock most people never hear about.

The general Georgia deadline for injury suits is two years. A claim against a city, county, transit authority or school district can require written notice in a fraction of that time, and it has to be in the right form and go to the right place.

Missing that notice can end an otherwise strong case before it starts.

Who owns the bus drives the analysis. A public bus, a school bus and a private charter are three different cases. Ownership sets the notice requirement, the immunity questions and the coverage available.

Video is the other clock. Buses are heavily cameredad, inside and out, and retention is often measured in days or weeks. Ask too late and there is nothing left to preserve.
