

When a rider is hurt and a driver did not see you in Georgia, the assumption is already working against you.

People arrive with a view already formed: that the rider was speeding, was lane splitting or weaving, or [truck accident lawyer](#) took a risk a car driver would not.

Sometimes that is accurate. Frequently the driver simply did not see the motorcycle and turned across it.

The work is physical evidence, not story, since the story is doubted before it is told. Scene measurements do the arguing.
