

When someone is shocked or burned on a job site in Georgia, the answer is rarely a single company.

There is the property owner, a general contractor, the electrical sub, sometimes the utility, occasionally an equipment maker, and sometimes a labor supplier. Each has different insurance and different incentives to point at the others.

Workers compensation pays medical bills and a portion of lost income when the injury is work related, and it bars a suit against your employer. It does not bar a claim against a third party whose conduct created the hazard.

The claim against the other company is normally where the meaningful money is, since comp covers none of the <https://files.fm/u/r9zy9rchuvpwqny2> human loss and only part of the financial one.

Establishing who controlled the hazard requires the site contracts and the safety documentation, none of which an injured worker can obtain by asking.

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery.
