

If a dog bit you in Atlanta, the rules may not be what you assume.

Some states hold the owner responsible no matter what. That is not the Georgia rule. Usually it comes down to whether the owner had reason to know the dog was vicious, or whether the dog was loose in violation of a local leash ordinance.

Establishing what the owner knew is not easy. People do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

Local ordinance violations are usually easier to establish, so the early questions focus on whether the animal was restrained and whether anyone contacted animal control.

These records fade fast. Animal control files and recollections both fade, and the animal may **Click here!** be rehomed or euthanized before its history is ever documented.
